The Louisiana Legislative Session began Monday, March 14th, and runs through June 6th. The budget instruments have passed the House and will be the main focus of the Senate for the coming weeks, as they assert their priorities in the way of amendments. Committee agendas will have large and controversial bill loads this week, with many bills still trying to pass their first hearing. Louisiana does not have a “cross-over” deadline, but if legislation does not pass its first hearing in the coming weeks, it is at risk of running out of time or being stalled.

The final five weeks of session will move quickly, and both the legislative days and weeks will become longer. I will work hard to report to you directly on action pending and as it occurs on the legislation you have expressed is a priority.
